Federal Defendants hereby notify the Court of an Investigative Report issued by the Department of the Interior's Inspector General on December 15, 2008 that may affect this action. The Report sets forth the Inspector General's findings from an investigation into former Deputy Assistant Secretary Julie MacDonald's influence on twenty Endangered Species Act ("ESA") listing and critical habitat decisions. The Investigative Report, entitled "The Endangered Species Act and the Conflict between Science and Policy," is the result of a second investigation into Ms. MacDonald's participation in the Fish and Wildlife Service's rulemaking activities under ESA Section 4 undertaken at the request of several members of Congress. The Report is available on the Office of the Inspector General's website.<sup>1/</sup>

The Report concludes that Ms. MacDonald, acting alone or in concert with other Department of the Interior officials, took actions that potentially jeopardized the ESA decisional process in thirteen of the twenty investigated listing and critical habitat actions. Among the thirteen listing and critical habitat designations is the final designation of critical habitat for the bull trout, 70 Fed. Reg. 56212 (Sept. 26, 2005), the rule Plaintiffs have challenged in this action.

As a result of this Investigative Report, Federal Defendants will be reviewing the decision and administrative record for this action to determine whether to continue this litigation, amend their litigation position, or pursue further administrative action with respect to the challenged rule. Within 45 days Federal Defendants will advise the Court of its progress in reviewing these determinations.
